

The Group / History







MG Precast is the Adria Region' leading precast concrete structures manufacturer. The company employs over 150 people in two locations - the Inđija production facility and the Belgrade design bureau.

Since the founding in 2007, MG Precast has been involved in almost every significant construction project in Serbia, dealing with both regional and international investors.

One of the highlights of the company is the Indija production facility - spread across over 40.000 square meters, it is comprised of two production plants with state-of-the-art automated production processes used in the manufacturing of elements for precast concrete structures.

Burnout d.o.o. and Burnout s.r.l. are the companies representing our Motorcycles segment. Burnout Serbia is the exclusive distributor for Ducati motorcycles in Serbia, Bosnia & Hercegovina and Montenegro. In addition, it is also the exclusive distributor of Benelli motorcycles in Serbia and SW-Motech motorcycle equipment products. Ducati and Benelli together account for a significant part of the market in terms of sold motorcycles.

Ducati Genova dealership and service center, owned and operated by Burnout s.r.l. is another key part of this operating segment. Aquired by the group in 2019. we were able to demonstrate high levels of growth in the first year since taking over.

Since founding, both companies have sold almost 1.000 motorcycles in Serbia, Italy, Bosnia & Hercegovina and Montenegro.




Loom of Fruit d.o.o. is a company that deals with the production of prestressed concrete pillars, formed from the merger of an Italian company with extensive experience in the area of industrial prefabrication and a Serbian company, with the sole aim of: offering fruit production companies a better quality-to-price ratio in order to match the increasingly competitive foreign market.

The company is located 100 km south of Belgrade, the capital of Serbia, extending over an area of 16.000m2 with a production hall of 4.000m2. The factory is located only 40 km from the city of Smederevo, which is one of the main locations in terms of river transport logistics via the Danube to the large ports of the Black Sea.
